MANUSCRIPT SUBMISSION GUIDELINES

All submissions must be in a Word format.

The title page is a separate Word file which includes:

- title of the article
- author's (and co-authors) full name, current position, affiliation, institutional and email address, ORCID number (in the upper right corner)
- up to five key words as it should appear if it were to be published (under abstract)

The article should be written using the following template:

- File type Microsoft Word
- Font Times New Roman, 12 point
- Line spacing -1.5v Margins -2.5
- Length including bibliography up to 20 standard A4 printed pages
- Manuscripts must be written in English or in Polish

Structure of the theoretical text

The abstract should not exceed 250 words. It should offer a concise, yet comprehensive summary of the manuscript's contents. Footnotes are to be numbered and only used for author's notes.

Structure of the text:

- (1) Introduction: presentation of the research problem based on the theoretical background.
- (2) Subheading
- (3) Conclusions.
- (4) References.

Structure of the empirical text

The abstract should not exceed 250 words. It should offer a concise, yet comprehensive summary of the manuscript's contents. Footnotes are to be numbered and only used for author's notes.

Structure of the text:



- (1) Introduction: a short presentation of the research problem based on the theoretical background.
- (2) Method. Participants (including: sample size, demographic characteristics, sampling method). Measures (including basic reliability and validity scores). Procedure Data analysis procedure.
- (3) Results: the most significant findings of the study.
- (4) Conclusions.
- (5) References.

Reviews and Reports

Up to five pages of standard manuscript.

Tables

Tables should be embedded in the manuscript file. Table formatting should follow the 7th ed. APA standards and should be created using the appropriate functions of text editing programs (e.g., Microsoft Word). Tables should not be embedded as graphical files, or pictures nor should they be constructed using spaces, line breaks, etc. Tables should contain captions and table notes, where necessary (under the table). The table note should explicate all abbreviations and acronyms used in the table so that the table is legible without reference to the main text. Tables should be introduced in the main text (e.g., "Table 1 shows...").

Figures

Figures and figure captions should be embedded in the manuscript file. The figures should be prepared in appropriate graphical editing software. Figures should be introduced in the main text (e.g., "Figure 1 shows..."). Figures should have captions. The captions should explicate all abbreviations and acronyms used in the figure so that the figure is legible without reference to the main text. Figure numbers and captions should follow the 7th ed. APA standards.

References

- References should follow the guidelines indicated in the Publication Manual of the American Psychological Association (7th ed.). Note: Use endnotes rather than footnotes.
- References to be placed within the main text and to include author's surname, date of publishing and page number/s, e. g. (Agnew, 2010, p. 1).
- When citing two books published by the same author in the same year, the following form should be used: (Agnew 2010a; Agnew 2010b).



- When the work of two authors is cited both surnames should be provided; when more than two authors exist the formulation 'et al.' should be used after the first author's name, e. g. (Agnew et al. 2007).
- If the author cites an Internet source, the following forms apply: (Agnew, T. (2014) title, website address and when (data) has been visited, or when there is no author or title, and there is only the website address, a footnote should be placed traditionally at the bottom of the page.

Declaration of conflicting interests

Archive of Social Sciences and Humanities encourages authors to include a declaration of any conflicting interests. In a consistent fashion under a separate heading.

A Declaration of Conflicting Interests policy refers to a formal policy a journal may have to require a conflict of interest statement or conflict of interest disclosure from a submitting or publishing author.

The Committee on Publication Ethics (COPE) states in its Guidelines on Good Publication Practice (2003) that:

'Conflicts of interest arise when authors, reviewers, or editors have interests that are not fully apparent and that may influence their judgments on what is published. They have been described as those which, when revealed later, would make a reasonable reader feel misled or deceived'

Funding

Archive of Social Sciences and Humanities requires all authors to acknowledge their funding in a consistent fashion under a separate heading. Like below:

This research received (or not) specific grant from any funding agency in the public, commercial, or not-for-profit sectors (No of Grant).

Additional information

- Articles will normally be referred by two external reviewers.
- You should expect to hear from the journal within 6-8 weeks of submission, after peer-review process has been completed.
